The purpose of the draft Law is to establish the legal and organizational basis for determining the territories of the Emerald Network and their management in Ukraine for the preservation of natural habitats and species of fauna and flora subject to special protection, legal and organizational basis for assessing the impact on the territory of the Emerald Network in the process of making decisions on the implementation of economic activities that may have a significant impact on the territory of the Emerald Network, taking into account public, public and private interests, legal and organizational foundations of the creation of a central body of executive power, which ensures the implementation of state policy in the field of protection and use of the nature reserve fund, ecological and Emerald networks, preservation of biodiversity, fulfillment of Ukraine's obligations under international treaties, consent to the bindingness of which provided by the Verkhovna Rada of Ukraine.


